**Master of Arts in Applied Linguistics Programme (2025/2026)**

1. Applications are invited for admission in September 2025 to read for the degree of Master of Arts in Applied Linguistics.
2. Our programme is designed for those who have professional experience in English language education although we welcome applications from non-teaching linguists or those with related professional experience in the analysis of language. The focus of the programme is on issues relating to the teaching, learning and use of English for academic or professional purposes. Some courses in the programme contribute to an understanding of English in all contexts, while others relate more specifically to the learning context in Hong Kong. The curriculum shall normally extend over one academic year of full-time study or two academic years of part-time study.

**Admission Requirements**

3. To be eligible for admission to the programme, a candidate shall satisfy both the University Admission Requirements and the Programme Specific Requirements as listed below:
  - (a) shall comply with the [General Regulations](#);
  - (b) shall hold a good Bachelor's degree of this University; or a qualification of equivalent standard from this University or another comparable institution accepted for this purpose;
  - (c) for a candidate who is seeking admission on the basis of a qualification from a university or comparable institution outside Hong Kong of which the language of teaching and/or examination is not English, shall satisfy the University English language requirement applicable to higher degrees as prescribed under [General Regulation G2\(b\)](#).

The programme has its specific requirements with regard to TOEFL and IELTS:

<u>Test</u>	<u>Minimum requirement</u>
TOEFL: Paper-based test (PBT)	Overall score of 550 with 4 in Test of Written English (TWE); or
TOEFL: Internet-based test (iBT)	Overall score of 80 with 25 in Writing; or
IELTS	Band 7 with no subtest lower than 5.5

Note: Only TOEFL/IELTS scores recorded in the two years before the date of application are considered. IELTS Indicator and TOEFL Special Home Edition are not accepted.

- (d) shall satisfy the examiners in a qualifying examination if required.
4. An application for exemption from the above requirements shall be considered on a case-by-case basis.

**Application**

5. Applications for this programme and payment of application fee (HK\$300 per application) should be submitted online at <https://portal.hku.hk/tpg-admissions>.

6. After submitting the online application, applicants are required to upload the supporting documents within one month starting from the date of receipt of the email notification. A checklist of the required supporting documents is available at <https://portal.hku.hk/tpg-admissions/programme-listing>.
7. In order to support the University's environmental friendly initiatives, documents uploaded to the system should NOT be delivered to the University by post in duplicate, unless you receive notification to submit your documents.
8. Applicants who do not hear from the Faculty of Arts by August 31, 2025 may assume their applications unsuccessful.

### **Concurrent Studies**

10. General Regulation G6(b)(i) prohibits concurrent registration by a student of this University for any other post-secondary qualification either at this University or at any educational institution, unless approval of the Senate has been obtained in advance. Students in breach of this regulation may be required to discontinue their studies at this University.

### **Visa for Studies**

11. All applicants without the right of abode/right to land in Hong Kong must apply for a student visa for the purpose of education from the Hong Kong Immigration Department (ImmD) before registration in our programmes. Normally the student visa is only granted to those admitted to full-time studies. Students are responsible for ensuring that they have a valid visa and register in the programmes before the study begins. If any student fails to register in time, the offer of admission may be withdrawn and all fees already paid will not be refunded.
