After submission of the application form via application portal, you will be redirected to [TOLA-ADDON](#) to upload supporting documents in PDF format. All documents should be uploaded within one month of your application date.

If you are currently enrolled in an academic programme and have not yet completed your qualification at the time of application, please submit your most recent transcript along with any other relevant supporting documents for immediate review.

[#] Applicants holding qualifications from Overseas (outside Hong Kong) may be required to submit e-copies of their academic documents via an online verification platform. This may include:

1. an official platform of the awarding institution; or
2. a third-party platform authorized by the awarding institution [e.g., Parchment, My eQuals, MyCreds, National Student Clearinghouse, Gradintelligence, Digitary, Higher Education Achievement Report (HEAR), World Education Services (WES), Academic Certificate Verification Platform (ACVP)].

[^] Applicants holding qualifications from Chinese Mainland are required to submit ALL of the following verification reports issued by [CHSI](#) / [CSSD](#) [中国高等教育学生信息网(学信网)] in both Chinese and English. Please make sure these reports remain valid for at least six months from the date of application:

1. Verification Report of China Higher Education Student's Academic Transcript (中国高等学校学生成绩验证报告), which contains complete records of the years of study and examination results;
2. Online Verification Report of Higher Education Qualification Certificate (教育部学历证书电子注册备案表);
3. Online Verification Report of Higher Education Degree Certificate (中国高等教育学位在线验证报告).

⁺ Starting from the 2026 intake, IELTS and TOEFL tests must be taken within two years prior to September 1 of each admissions year.

For TOEFL score report, apart from uploading a scanned copy, please also request it to be sent electronically from Educational Testing Service (ETS) website, for verification purposes.

* Submission of reference letters is optional. No invitation emails will be sent to referees. If available, the letters may be uploaded under "Other Documents".

Transcripts, diplomas, certificates and other submitted documents which are not in English should be accompanied by a certified translation in English. Certified translation may be provided by your home institution.

Submission of originals of your documents is **not** necessary at the time of application. You may be asked to submit them if your application is accepted.

In addition to the supporting documents listed above, all applicants **MUST** upload a copy of duly signed and dated [Personal Information Collection Statement](#). This is a **MANDATORY** requirement to confirm your understanding of the relevant data collection policies.
